For use when providing stud services to a dam.

THIS CONTRACT IS FOR A STUD SERVICE. If a deposit is required, it is due upon execution of this contract. Balance shall be in accordance with option selected above. Litter registration papers will not be signed unless Stud Fee and any associated veterinary or other agreed upon expenses are paid in full.

**DEFINITION OF "LITTER"**

A Litter, for the purposes of this Contract, is defined as a minimum of 2 puppies born alive. If Litter results in only one puppy, and the Bitch Owner does not wish to repeat the Breeding, the deposit paid prior to Breeding, plus expenses, will be considered payment for a one puppy Litter and the Contract is fulfilled.

**STUD OWNER AGREES TO:**

1. Provide dam owner with copy of stud's AKC certificate.

2. Provide dam owner a copy of stud owner's current driver's license.
3. Provide dam owner with a copy of stud's 4 panel health certificate.
4. Have the stud dog in good physical condition, current with annual vaccinations.
5. Sign litter registration promptly and return to dam owner.
6. The contract is for the original insemination. Should the dam not have a live birth, stud owner will provide an additional semen specimen at the soonest available heat that is recommend for pregnancy. If the stud is no longer available for whatever reason for the return service, the stud owner or agent reserves the right to offer a different stud to the dam owner. Should the dam not conceive and have a live birth after the second insemination, the contract is fulfilled.
7. Agree to cross post images and videos of resulting puppies from breeding.

**DAM OWNER AGREES TO:**

1. Pay the agreed stud service fee.
2. Provide stud owner with a copy of dam's AKC certificate.
3. Provide stud owner a copy of dam owner's current driver's license.
4. Keep dam current with all required annual vaccinations.
5. Notify stud dog owner/agent, in writing, no later than 63 days after mating if no pregnancy results from the mating. Failure to do so will result in no return service being provided.
6. Keep the dam properly confined following the breeding to ensure no other dog could mate her accidentally before mating season is finished.

Dam Owner is responsible for all testing done to the dam prior to and during Breeding to assure the proper timing of said Breeding. If Stud Dog is able to perform naturally and for some reason the Dam Owner asks for artificial insemination or the dam cannot be bred naturally, dam Owner is responsible for cost of said process. If dam Owner is not willing to pay for progesterone testing, smears or AI's this should be stated ahead of time and included in the contract initialed by both parties. If this is the case, we will try our best to breed the dogs at the proper time but if no puppies result the deposit is forfeited, and no repeat breeding is offered.

It is understood this contract ONLY applies to original buyer and is NOT transferable.
